1. <u>CATEGORY OF POST</u>	<u>EDUCATIONAL QUALIFICATION.</u>
<u>Village Revenue Officer</u>	Must have passed Intermediate Examination conducted by the Andhra Pradesh State Board of Intermediate Examination or its equivalent Examination and the candidates shall be the native district which the Recruitment is notified.
2. <u>AGE:-</u>	The applicant should have completed (18) years of age as on 01.07.2011 and should not have completed (34) years of age as on the said date. (in case of SC / ST / BC maximum age limit shall be 39 years)
3. <u>SCALE OF PAY:-</u>	Rs.7520-22430 in the PRC-2010 scales.
4. <u>Method of Selection:-</u>	The Selection of candidates is based on a objective type Written Test for 100 Marks at Intermediate level.
